Part IV – AUTHORIZATION, RELEASE and WAIVER

I hereby represent and warrant that I am the sole registered and beneficial owner of the above described property, or if there is more than one registered or beneficial owner, am duly authorized to enter into this Automotive Liability Release Form on behalf of such other registered or beneficial owner(s) (together the “Owners”) and bind them to the agreements contained herein, and in such capacity I agree that:

1. The Seventh-day Adventist Church (British Columbia Conference), operating as the Church in the Valley (the “Church”) is authorized to use, service, repair and/or clean the Vehicle as set out in Part III, above (the “Work”).
2. The Vehicle and any related or ancillary equipment may be operated by any employee or volunteer of the Church with a valid driver’s license.
3. I have disclosed to the Church all known or suspected defects in the Vehicle of any kind that could affect or impact on the safe operation of the Vehicle. I have removed all personal items from the Vehicle and agree that any personal items or property of any kind remaining in the Vehicle are at my risk of loss or damage.
4. (a) The Church is a voluntary, charitable organization, not regularly engaged in the business of operating a garage, service station and any servicing and/or repair of motor vehicles. (b) All Work will be effected and performed by volunteers associated with or persons employed by the Church and the scope of Work will be limited to that which the Church can properly perform as part of its charitable operations as permitted by the *Income Tax Act* (Canada). (c) The volunteers or employees of the Church engaged in any part of the Work may not (and often will not) be trained or licensed mechanics and the Church makes no representation and gives no warranty that the Work will be complete or that

any defects or problems with the Vehicle will be detected or repaired. I acknowledge that the Church recommends that I also bring the Vehicle to a licensed and trained mechanic for a full inspection for any defects or deficiencies in the Vehicle. (d) Motor vehicles are and contain complex equipment, machinery and systems that may be negatively impacted or affected by the Work and, on behalf of all Owners, I accept the risk of any loss, harm or damage to property (including the Vehicle) or personal injury that may result or arise from, be related to or be in any way connected with the Vehicle or he Work; (e) I, on behalf of myself and all Owners, waive, release and forever discharge the Church and all of its affiliates, members, directors, officers, leaders, agents, volunteers and employees (the "Releasees") from any actions, causes of action, suits, claims, losses, expenses and demands, whatsoever, (each a "Claim" and together "Claims") that I or any Owners or our successors, heirs or assignees have now or may have of any kind (including without limitation for negligence or gross negligence and/or relating to personal injury, death or harm or damage to property) that arise from, related to or are connected in any way with the Vehicle, property remaining in the Vehicle or the Work, including without limitation any Claims for improper or faulty servicing and/or repair of the Vehicle or any components thereof and for damage to or loss of the Vehicle or any components thereof or any property remaining in the Vehicle when in the care, custody or control of the Church or any other Releasees. (f) I agree to indemnify and hold harmless all Releasees from and against and Claims that I or any third party may have against any of them as a result of, arising out of or in any way connected with matters released in this Automotive Release Liability Form.

5. I authorize the Acts of Kindness and/or Church to use my **photo** (and/or that of my children named on this waiver) for promotional materials including, but not limited to newsletters, newspaper articles, web pages, brochures, videos, and other media presentations.

6. I, the parent / guardian of the above mentioned **children**, hereby give permission for the above mentioned children to participate in any or all of the Following activities at Church including Rock-climbing, playing in the indoor sports court, bouncy castles, playing on the outdoor playground or other activity at church in the valley whether led by a Church volunteer or employee or not. I acknowledge that any sport or play activity has inherent risks including death and serious injury.

7. I have carefully read and understand all of the provisions of this Automotive Release Liability Form and agree to it on behalf of all Owners. If any provision hereof is invalid, illegal or incapable of being enforced by reason of any rule of law or public policy then such provision will be severed from this document and will not affect any other provision contained herein and all other provisions will remain in full force and effect.
